





Proof of Insurance

- Remove these cards along the dotted lines. Keep one card in the vehicle at all times.
- This is a personal lines motor vehicle policy. The proof of coverage information has been reported
 electronically to the Department of Vehicle Regulation. In the event that your Vehicle ID Number
 (VIN) does not appear in the database, you may be required to present a copy of this insurance
 card to the county clerk for issuance of a replacement plate, decal or registration certificate or
 renewal as alternative evidence of proof of coverage.
- Make sure the VIN on your vehicle, your registration, insurance policy and this card match.
 - If the VIN on the motor vehicle title and registration does not match your vehicle, contact your county clerk to have your title and registration corrected.
 - If the VIN on the insurance policy, this card and your vehicle do not match, contact your agent to have the insurance policy and this card corrected.


