- Protect around perimeter of structure, there could still be some plant damage etc
- Remove existing roofing (one layer of shingles), vents etc and dispose of all debris
- Install ice and water barrier up 6' from fascia or 2' into heated space per code
- Install new synthetic felt and architectural shingles
- Install new vents and ridge cap
- Due to the nature of roofing projects, extra material is always ordered. Any leftover material after the project is completed does not reflect the project being smaller than estimated, and will not be refunded
- Roof decking will be replaced on a time and materials basis
- Any other repairs will be done at \$80/hr
- Complete clean up and removal of debris
- Run a magnet over yard in work areas
