1. A person shall not:

- a. Operate a motor vehicle registered or required to be registered in this state without having security covering the vehicle as required by Chapter 485 of the Nevada statutes.
- b. Operate or knowingly permit the operation of a motor vehicle without having evidence of current insurance in the vehicle.
- c. Fail or refuse to surrender, upon demand, to a peace officer or to an authorized representative of the department proof of security.
- 2. Except as provided in Subsection 4, any person who violates Subsection 1 shall be fined not less than \$600 or more than \$1,000.
- 3. A person may not be fined if he presents evidence to the court that proof of financial responsibility required by NRS 485.185 was in effect at the time demand was made for it.
- 4. Failure to deposit security if so required by the provisions of NRS 485.190 is prima facie evidence of violation of the provisions of this section.
