### Important Notice

Any person operating a motor vehicle upon a highway or upon property open to use by the public shall display, upon demand, evidence of financial responsibility to a law enforcement officer. Evidence of financial security shall be provided by a policy of motor vehicle liability insurance, an identification card or certificate of insurance issued to the policyholder by the insurer which provides the name of the insurer and the policyholder.

Any person violating any provision of this law shall be guilty of a class B misdemeanor, except that any person convicted of violating this law within three years of any prior conviction shall be guilty of a class A misdemeanor.
