Understanding Coverage Choices

Below are general descriptions of types of insurance coverages. You'll want to consult your policy for terms, conditions and limits of your own insurance coverages.

Boat Insurance

Emergency Services - Up to \$3000 for the reasonable cost for emergency like towing, labor and fuel.

Personal Effects - Covers physical loss to personal effects owned by an insured person while on board of the insured watercraft.

Watercraft Liability - If you injure someone or cause damage to another's property while operating your watercraft, Liability Coverage helps pay expenses if you're legally responsible.

Medical Payments - Can help pay for medical expenses resulting from injuries received in a boating accident or for water skiers being towed by your boat or swimmers off your boat.

Your Property - Pay for damage as a result of a covered accident to your boat, motor, boat equipment, and boat trailer.

Repair Cost Option - Coverage for partial losses to repair or replace.

Uninsured Watercraft - Coverage for hit-and-run, uninsured or underinsured boats within policy limits.
