Once you reach the desired Licensing Level, the agreement automatically reverts to a month-to-month agreement with a 30-day written notice cancellation provision.

TERMINATION:

Upon the termination of this Agreement, you agree to stop all use of our Confidential Information for any purpose without the prior written consent of ProGlobal Business Advisors and Leader Publishing Worldwide.

You agree to return all copies of such Confidential Information and provide a signed Declaration confirming that all such copies have been returned - including the book(s), Focus Group materials, marketing portfolios, etc., we create or provide for you.

DEFAULT:

You are in default if your payment is declined by your bank or credit card company for any reason. There is a \$50 fee to reprocess your charge. If the default is not cured within 3 days, you will incur an additional 10% monthly late fee of the total amount due. If the default is not cured within 30 days, your account will be turned over to a collection agency for collection. You will be responsible for all fees associated with the collection of the amounts owed. This includes collection fees and costs, attorney fees, late fees, and any other remedies allowed by law. We may also report your account to the 3 major credit bureaus as a collection.
