## Contract: Get Responses And Closings

### Date Field

This contract constitutes the agreement between the PARTNER (detailed below) and the SERVICE PROVIDER, American Elite Services LLC .

In return, the PARTNER agrees to pay the amounts and percentages listed and signed for below. In the case of alterations, service changes, interruptions, or disputes, by either party the changes or remedies will be addressed in an amendment to the contract (see below).

The data entered into the system is the property of the PARTNER, to be protected in accordance with our terms and privacy policies. At the termination of the contract, or in case of suspended services, SERVICE PROVIDER, will continue to store and protect that data for the period of one year for the PARTNER'S benefit, after which the data will be wiped, and the account deleted.

Both parties agree in the case of unresolved dispute, that the remedy of first resort will be to involve a para legal counselor in a dispute resolution arbitration.
